Pursuant to the issuance of Statutory Instrument No. 112 of 2021 - The Road Traffic (Fees Regulation) on 30<sup>th</sup> December 2021, and publication of the SI in the Government Gazette, the Road Transport and Safety Agency (RTSA) wish to announce the adjustment of Road User Fees chargeable by the Agency upwards by 10 percent. The SI will take effect on 31<sup>st</sup> January, 2022.
